Dissertation Topic

Coping With Limits: Responding to Reform in Oklahoma. This is a case study of the Oklahoma Legislature's institutional response to term limitations. In the early 1990s many pundits and scholars offered speculation regarding the likely effects of legislative term limits. This project is one of the first to bring data to bear on the speculation. The research involves both quantitative and qualitative methods. It finds that term limits are neither the panacea that proponents suggest nor the Pandora's box that opponents predict.
